Admission, Maintenance, and Graduation Requirements

- Must have Bachelor’s degree in Elementary Education from a regionally accredited college or university
- Must provide documentation of appropriate, professional test scores
- Must have a minimum of 18 hours of undergraduate courses in the field in which the graduate degree will be pursued.
- Must maintain a 3.0 GPA throughout program
- Must have Class A Certificate issued by a state department of education, or must have completed a teacher education program accredited by NCATE. A photocopy of the standard Educator License is required.
- Must have passing scores on the Praxis I and II in the area of major.
- At least 50% of courses in the program must be taken at the 6000 level.
- No degree requirement may be waived without the approval of the Graduate Dean.
- Make an application for graduation with the Registrar’s Office.
- Apply for Oral-Written Comprehensive Examination with the Graduate Office.
- Send all official transcripts from previously attended colleges or universities to MC Grad Admissions office.

At the END of the last semester, fill out a transcript request form and application for licensure through the department of Education website on the Electronic Licensure Management System (ELMS). If you are receiving an additional endorsement, you may pick up a licensure endorsement form from the Office of Field Experiences. You are responsible for gathering and submitting the required information to the Mississippi Department of Education.
