They must successfully complete two consecutive internships in which they are supervised by our faculty, full-time or adjunct, in order to be eligible for a 5-year renewable license.

Once an individual has met all the requirements of a state-approved teacher preparation program and becomes a program completer, the individual is no longer classified as enrolled.

Annual Goals - Mathematics
